## HOUSE RENT ALLOWANCE IN RESPECT OF IAF OFFICERS

1. Consequent to the recommendations of Vth Central Pay Commission, Govt has sanctioned Hou in respect of Armed Forces Officers vide Govt of India, Min of Def letter No. 1(5)97/D(Pay/Sers) dated 2 Sep 97 modified vide Govt of India, Min of Def letter No. 10(55)/98/D(Q&C) dated 29 Sep 99 (copy attached as This will be admissible on the same scales as applicable to other Central Govt Employees notified for civ MOF OM No. 2(30)/97-E II(B) dated 03 Oct 97, when accommodation under the existing arrangements is provided. Officers whose place of duty falls within the qualifying limits of a city or within contiguous or agglomeration of that city shall be eligible for HRA irrespective of whether his place of residence is within or out side.

### ELIGIBILITY CONDITIONS

2. The admissibility of HRA will be subject to the following conditions :-



Note : The payment of HRA where reserved accommodation is left vacant / not occupied by the entitle other reason, will be held in abeyance till necessary clarification is received from Min of Def for wh referred to Min of Def.

### RATE OF HOUSE RENT ALLOWANCE

3. The House Rent Allowance will be admissible at the rate as given below :

<u>Classification of cities/towns</u>	<u>Rate of HRA</u>
A-1	30% of Basic Pay + Rank Pay + NPA
A,B1,B2	15% of Basic Pay + Rank Pay + NPA
C	7.5% of Basic Pay + Rank Pay + NPA
Unclassified	5% of Basic Pay + Rank Pay + NPA

Note : Stagnation increment forms a part of basic pay as per SAFI 2/S/98.

### ACTION BY CLAIMANT

4. Every officer shall submit a personal application for claiming HRA. The officer shall fu application a certificate in the form given in appendix 'A' to C Adm O / Allotting Authority. The offic an application to the Stn Cdr for issue of NAC for claiming HRA as per appendix 'B'. Officers whose f

at selected place of residence in non military station under own arrangements would be required to submit appendix 'A' and appendix 'D' alongwith their application. Appendix 'C' or 'D'; as applicable would be submitted to the Adjutant on six monthly basis by the affected officer. As and when the officer is allotted with Govt accommodation, he is to inform the same to S Accts O. He is not to receive the amount credited in IRLA and reflected in HRA from the date of allotment of Govt accommodation to avoid overpayment and debit balance in future.

#### ACTION BY C ADM O / ALLOTING AUTHORITY / COMPETENT AUTHORITY

5. As soon as the officer submits his application for allotment of Govt accommodation, C Adm O / Competent authority shall scrutinise the application and also the position of available accommodation in the station pool. If no married accommodation is available, the officer is to be issued a NA certificate as per appendix 'C'. The NA certificate is to have annotation of the fact that it will remain valid as long as no accommodation is allotted to the officer. A copy of the NA certificate is to be forwarded to the Adjutant.

6. On allotment of Govt accommodation to the officer, forward a copy of the allotment order to S Accts O with a copy to S Accts O to enable him to restrict the amount credited in officer's pay slip on account of allotment of Govt accommodation.

7. After the allotment of Govt accommodation is accepted by the officer, HRA should be ceased at the place of acceptance.

#### ACTION BY ADJUTANT

8. On the basis of NA certificate issued by C Adm O/Allotting authority/Competent Authority as per appendix 'C', the Adjutant will promulgate the POR authorising HRA indicating the rate of HRA as applicable and the date of entry is to be promulgated under Section-I of the main POR. The POR should mention that certificate as per appendix 'C' to DACL has been rendered by the officer. When the officer opts to retain his family at SPR the POR will mention the rate of HRA applicable at that place. A certificate from the officer countersigned by CO/OC Unit should be submitted to the Adjutant twice in a year on 31 Mar and 30 Sep as per appendix 'C' or 'D' as applicable. The date of authorisation/cessation of HRA and outstation HRA are given in appendix 'E' to this DACL.

9. On receipt of allotment order for Govt accommodation from C Adm O/Allotting Authority, the Adjutant should promulgate the POR.

10. HRA is to be ceased as and when the officer is posted out.

#### ACTION BY AFCAO

11. Necessary credit will be afforded in the IRLA by AFCAO on receipt of authorisation POR for same will be ceased on receipt of cessation POR.

#### ACTION BY SAO

12. Payment will be made on A/Roll in arrears alongwith monthly pay. On receipt of intimation of Govt accommodation from the claimant / C Adm O, payment of HRA is to be restricted till the date same in IRLA to avoid debit balance and overpayment.

#### GENERAL

13. The provision of Govt letter under reference will be effective from 21 Nov 97. However past cases have already been passed will not be re-opened.

14. HRA is taxable as per Section 10(13A) of IT act and rule 2(A) of IT rule as amended from time to time. Taxpayers desirous to claim exemption may do so by declaring the actual rent paid indicating the month wise supported by a proof of rent receipt, through IT deduction form as per appendix 'A' to DACL 48/94. Statement to reach AFCAO not later than 31 Dec each year. Based on the declaration, AFCAO is to provisionally reckon actual rent paid upto the month of Dec every year. Refund if any due in respect of Jan and Feb may be claimed directly by the assessee by submitting the IT return.

HOUSE RENT ALLOWANCE IN RESPECT OF ARMED FORCES OFFICERS

Sir,

I am directed to say that consequent upon the decision taken by the Govt on House Rent Allowance for armed forces officers, orders were issued vide Govt of India, Min of Defence letter No. 1(5)/97/D(Pay/Service

and letter No. 10(55)/98/D(Q&C) dated 21 Jul 98 laying down terms and conditions regulating payment HQs have, however, pointed out the following difficulty in implementation of the above orders and re detailed letter covering these issues and all other aspects related to the payment of HRA :-

- (a) Pay for the purpose of HRA has not been specified which should include Basic and Non Practicing Allowance, wherever admissible.
- (b) HRA is governed by place of posting. Hence an officer posted in field/ operational area not provided accommodation will be entitled to HRA as per the rental of unclassified area which is 5% of actual basic pay. Inadequate compensation for the most deserving category.
- (c) Married officers staying in officers Mess, because of constraint of service and not occupying Govt accommodation anywhere are not entitled to HRA. This practically debar all married officers from HRA.
2. Keeping in view of the above difficulties pointed out by HQs, the matter has been examined by Defence in consultation with Ministry of Finance and it has been decided to regulate payment of HRA in the following manners.

2.1 The rates of HRA for different class of cities will be as under :-

<u>Classification of cities/towns</u>	<u>Rate of HRA</u>
A-1	15% of pay
A	15% of pay
B-1	15% of pay
B-2	15% of pay
C	7.5% of pay
Unclassified	5% of pay

The list of cities/towns classified as A-1, A, B-1, B-2 and C for the purpose of HRA will be on the basis of the list issued by the Ministry of Finance for employees on the civil side.

2.2 Pay for the purpose of these orders will be the pay drawn in the prescribed scale as Basic Pay + appropriate rank and Non Practicing Allowance (NPA), wherever admissible.

2.3 Armed Forces Officers, whose place of duty falls within the qualifying limits of a city or within an urban agglomeration of that city shall be eligible for HRA irrespective of whether his place of residence is in the city or out side.

2.4 HRA to Armed Forces officers will be admissible under the following conditions :

(a) The family of the officer has not been allotted with any type of accommodation, such as Pool Accn, Separated Family Accn(SFA), Temporary Accn, Hired Accn, accommodation on a rented basis including own accn.

(b) HRA will be governed by the place of posting of the officer including Non Military Station. In respect of officers posted to Ops/field area/modified areas HRA may be allowed at the rates applicable for a Non Military Station/selected place of residence (SPR) provided the officer has not been provided with family (SF) accommodation. HRA will cease to be drawn from the date from which an accommodation is allotted for the family of the officer. HRA for the family at the rate applicable for selected place of residence or other wise admissible may be allowed if the family actually resides, at that place and the factuality is verified periodically by the competent authority and no accommodation certificate is granted by the competent authority about the availability of accn for the family at that place.

(c) The officer should not have refused any married accommodation including SF accommodation or selected place of residence, either allotted to him or hired for him.

(d) If an officer after acceptance, fails to take possession of Govt Accn within 10 days of receipt of allotment letter, license fee shall be charged from him from such date upto a period of 20 days. HRA for a period of 20 days from the date of allotment may not be paid to the officer. HRA after 20 days from the date of offer of allotment letter only if no accn certificate (NAC) is issued by the competent authority in respect of Govt residential accn in that station.

(e) Every officer, shall furnish alongwith his first claim for HRA a certificate in the form 'A' to the CDA (O)/paying authority.

(f) The officer shall also submit an application to the Stn Cdr for issue of NAC for claim Annexure 'B'. NAC as at Annexure 'C' will be issued by the Stn authorities.

(g) Officers whose families are residing at selected place of residence in non military arrangements would be required to submit a certificate as per Annexure 'A' and Annexure 'D' at claim.

(h) Annexure 'C' or 'D' as applicable would be submitted to the paying authority on six months affected officer.

3. All other provisions not covered in this letter would be applicable to service officers as applicable Govt Employees.

4. The provisions of the letters dated 21 Nov 97 and dated 21 Jul 98 stand modified to the above extent of this letter will be effective from 21.11.97. However, past cases wherein claims have already been reopened with the issuance of this letter.

The said recommendation since been considered by the Government in the light of the recommendations of the Committee, specifically the above subject, and it has been decided that while the existing pay scale of Sgt of X Group in the Air Force at Rs.4670-85-5945, those Sgts, of X category who qualify a technical examination at par with diploma holders designed and conducted by Air HQ will be given the upgraded scale of Rs.5000-100-6500.
