<u>Instruction for Members:-</u>

1. Definition of term 'family' as given in Para 5 of Chapter -7 of IAP 3601 is reproduced below :-

Family means :-

(i) In the case of a male subscriber, the wife, parents, children, minor brother(s), unmarried sister(s), deceased son's widow and children and where no parent of the subscriber is alive, a paternal grandparent. Provided that if a subscriber proves that his wife has been judicially separated from him or has ceased under the customary law of the community to which she belongs to be entitled to maintenance, she shall henceforth be deemed to be no longer a member of the subscriber's family in matters to which these rules relate unless the subscriber subsequently intimates in writing to AFGIS that she shall continue to be so regarded.

- (ii) In the case of a female subscriber, the husband, parent, children, minor brother(s), unmarried sister(s), deceased son's widow and children and where no parent of the subscriber is alive, a paternal grandparent. Provided that if a subscriber by notice in writing to AFGIS expresses her desire to exclude her husband from her family, the husband shall Henceforth be deemed to be no longer a member of the subscriber's family in matter to which these rules relate unless the subscriber subsequently cancels such notice in writing.
- **Note:** Child means legitimate child and includes an adopted child where adoption is recognized by the personal law governing the member or a word under the Guardians and Wards Act, 1890 (8 of 1890) who lives with the member and is treated as a member of the family and to whom the member has, through a special will, given the same status as that of a natural born child.
- 2. Col. 4. If only, one person is nominate, the words "in full" should be written against the nominee. If more than one person is nominated, the share payable to each nominee over the whole amount of the Insurance benefits shall be specified.
- 3. Col. 5. Death of nominee(s) should not be mentioned as contingency in this column. Some of the contingencies are- Divorce, Insanity, self Marriage, etc
- 4. Col.6. Do not mention your name.
- 5. Draw line across the blank space below last entry to prevent insertion of any name.
